The project involves improvements to existing habitats and creation of new habitats and has been devised to focus on benefitting three species listed in Section 7 of the Environment (Wales) Act 2016, namely bees and other pollinators, bats and hedgehogs and also trees. Key outcomes: use narrative and metrics where possible	In addition to maintaining and enhancing biodiversity and promoting the resilience of eco systems, the Project will also benefit residents in the village with environmental improvements contributing to general wellbeing and with organised activities and events improving community cohesion.
	It is anticipated that the Project will benefit three species listed in Section 7 of the Environment (Wales) Act 2016, namely bats bees and hedgehogs, to be better catered for and sustained as a result of the Project. The planned installation of bat boxes around the village including maternity roosts should continue to give long term benefit. Additional planting should strengthen the bee population in the village, and we hope to monitor this by asking residents to take part in The Great British Bee count and by sharing their findings with the community. We expect that by participating in the Project residents have increased awareness and understanding of biodiversity and eco-systems and also be better connected to their community and this community cohesion will continue beyond the funded period.
Review points, for e.g. enablers and barriers to action, improvements to forward plan	The Landfill Disposal Project profile and the Wales Council for Voluntary Action monitoring requirements facilitate and prompt regular detailed review the review of the Project. In addition, the Village Plan is regularly reviewed and updated. Consequently, enablers and barriers to action and/or improvements to forward plan are identified, recorded and addressed such as financial constraints or requirements for improved forward planning and communication within the volunteer group to assist with achieving the Project outcomes and Village Plan objective to protect the environment and open spaces.
How and when will the s6 duty be monitored and the s6 plan reviewed?	A key requirement of the grant funding involves sharing the successes and challenges of the Project to enable the Wales Council for Voluntary Action to demonstrate and publicise what the Landfill Disposals Tax Communities Scheme is delivering for the benefit of communities in Wales. Consequently, detailed 6 months returns are completed which effectively monitor and review compliance with the S6 duty. In addition, HKCC undertake regular reviews of the Village Plan including delivery of key objectives to ensure a objectives are achieved.
